MINUTES

1. CALL TO ORDER / ROLL CALL

Mayor Adkins called the special meeting of the Medina City Council to order in the Medina Council Chambers at 5:30 p.m.

ACTION: Motion Lee second Morcos; Council approved the meeting agenda as presented.

2. EXECUTIVE SESSION

ES-1: RCW 42.30.110 (1)(i) 5:30 - 5:45 PM

To discuss with legal counsel representing the agency matters relating to agency enforcement actions, or to discus with legal counsel representing the agency litigation or potential litigation to which the agency, the governing body, or a member acting in an official capacity is, or is likely to become, a party, when public knowledge regarding the discussion is likely to result in an adverse legal or financial consequence of the agency.

- Undergrounding Utilities (February 26, 2018 Study Session)
- Streets/Sidewalks

City Manager Michael Sauerwein reported that Andy Swayne, Municipal Liaison Manager with PSE, will give a presentation at the February 26 study session to discuss options and the process for undergrounding utilities.

Councilmembers discussed View and Sunlight and by consensus directed the City Manager to reach out to Bellevue's Neighborhood Conflict Program volunteers and invite them to come speak at a future meeting.

Councilmembers discussed Council Committees Personnel, Finance, and Public Works/Facilities. Councilmembers Frey and Wen volunteered for the Personnel Committee and Councilmembers Lee and Rossman volunteered for the Finance Committee. Council cancelled the Public Works/Facilities subcommittee.

Councilmember Wen proposed that Council review the tree code and make amendments to critical areas to protect slopes from landslides. There was a consensus to have Councilmember Wen and Rossman meet with staff to discuss and report back to the rest of the council.
