# MEDINA CITY COUNCIL SPECIAL AND REGULAR MEETING MINUTES

### **SPECIAL MEETING**

The December 12, 2011 Special Meeting of the Medina City Council was noticed pursuant to RCW 42.30.080. The meeting was called to order at 5:33 pm. Mayor Jordan immediately recessed meeting into executive session pursuant to RCW 42.30.140(4)(a) and (b) for the purpose of labor negotiation and discussions for an estimated time of 30 minutes. Council members Boyd, Dicharry, Jordan, Lee, Lee, Nelson and Phelps; city manager, city clerk, police chief, city attorney and special counsel Cabot Dow were present. Executive session expired at 6:03 pm and community reception was held honoring outgoing council members Jordan, Nelson and Whitney until 6:30 pm.

### **REGULAR MEETING**

### **CALL TO ORDER**

Mayor Bret Jordan called the December 12, 2011 Regular Meeting of the Medina City Council to order at 6:30 pm.

Mayor led members of the audience, council members, and staff in the Pledge of Allegiance.

City clerk administered Oath of Office to Mr. David Lee who was elected to serve Medina City Council position number two short and long terms.

### APPROVAL OF MEETING AGENDA

MOTION NELSON AND SECOND DICHARRY TO APPROVE AGENDA AS PRESENTED AND MOTION CARRIED 7-0 AT 6:32 PM.

#### PUBLIC COMMENT

Mayor read guidelines concerning public comment period and opened floor to public comment at 6:33 pm.

Medina resident Wilma Edmonds thanked Mayor Jordan for his outstanding leadership over the years and presented him the first document she received documenting City Hall remodel.

Medina resident Scott Hannah commended Mayor Jordan and council members for their professionalism in the handling of the Jeff Chen affair.

Medina resident Heija Nunn read into the record a statement which thanked council members for their service, expressed disappointment in a council-hosted staff appreciation party and raised questions related to the Chen employment matter. Ms. Nunn provided a disc to the City containing ten minutes of video from the June 13, 2011 council meeting.

Mayor closed public comment period at 6:39 pm.

Development services director summarized proposal.

Phelps requested study session agenda item to discuss tree code in order to define work for the planning commission. Council directed moving unfinished 2011 items to 2012 work plan.

MOTION DICHARRY AND SECOND BOYD TO ACCEPT PROPOSED PLANNING COMMISSION WORK PROGRAM WITH ADDENDUM THAT PROPOSED ITEMS 6, 7, 8, AND 9 FROM 2011 PLAN BE RETAINED AT A LOWER PRIORITY. MOTION CARRIED 7-0 AT PM.

## 2012 Park Board Work Plan (7:10 pm)

Public works director summarized proposal. Council agreed to remove "Review 84 Avenue Northeast (Northeast 12 to Northeast 24) street improvement design plans and provide input" and to consider it in the future under new item titled "other tasks assigned by city council".

MOTION BOYD AND SECOND D. LEE TO ACCEPT PROPOSED 2012 PARK BOARD WORK PLAN, REMOVING THIRD ITEM, ADDING FINAL ITEM "OTHER ACTIVITIES AS ASSIGNED BY COUNCIL", AND TO HAVE PUBLIC SURVEY FOR PARKS AND OPEN SPACE ELEMENT OF MEDINA COMPREHENSIVE PLAN TO OCCUR AT AN OPEN HOUSE. MOTION CARRIED 7-0 AT 7:18 PM.

Council member Boyd proposed a motion and D. Lee seconded the motion to accept proposed 2012 park board work plan, removing third item, "Review 84 Avenue Northeast (NE 12 to NE 24) street improvement design plans and provide input," and adding a final item titled "Other activities assigned by council."

Council member Phelps proposed amendment to motion to amend item, "Complete update to Parks and Open Space Element of Medina Comprehensive Plan following public survey and open house for public comment on draft plan...." to have a public survey occur at the open house. Council member Dicharry seconded proposed amendment and council members Boyd and D. Lee confirmed approval of amendment.

Development services director and building official summarized proposed ordinance and answered questions.

MOTION NELSON AND DICHARRY SECOND TO APPROVE AN ORDINANCE OF THE MEDINA MUNICIPAL CODE AMENDING SECTION 503 OF THE INTERNATIONAL FIRE CODE AND SECTION 17.72.090 OF THE MEDINA MUNICIPAL CODE RELATING TO FIRE APPARATUS ACCESS ROAD STANDARDS. MOTION CARRIED 7-0 AT 7:25 PM.

Executive session was extended 10 minutes at 9:35 pm.

City council members Jordan, Boyd, Dicharry, Lee, Lee, Nelson, and Phelps were present. Also in attendance were city manager and city attorney.

Executive session concluded at 9:45 pm and the regular meeting immediately reconvened.
