HAZARDOUS TREE DESIGNATION INSTRUCTIONS

PROCESS:

Step 1 - Complete and submit the hazard tree designation application to City Hall. A hazardous tree designation is decided by the City Arborist. The application is reviewed to verify information and identify if additional information is required.

Step 2 - City staff will contact the City Arborist and City Arborist will schedule a date to conduct a site visit.

Step 3 - City Arborist completes the assessment of the tree(s), prepares a report and delivers the report to the city. The city will send a copy of the report to the applicant. The City Arborist may authorize hazard pruning to mitigate a high risk rather than removing the entire tree, if feasible. If the city arborist assesses a tree to have a high or extreme risk and risk mitigation through pruning or moving of potential targets is not feasible, the City Arborist shall designate the tree a hazard tree.

Step 4 - The property owner may remove a hazardous tree, but a tree activity permit must be submitted in conjunction with the hazard tree removal.

Step 5 – Submit a tree activity permit for the removed tree. The property owner is required to provide mitigation pursuant to the requirements in MMC chapter 20.52 or 20.66.

FEES:

The fee will cover up to three (3) tree risk assessments. Please call the Development Services Coordinator for the most current fees - (425) 233-6414.

SUBMITTAL REQUIREMENTS:

A hazardous tree designation submittal package includes one of the following:

Completed application form, pages 3 and 4, attached.

Site plan or property aerial image from King County Parcel Viewer) with the following items indicated:

 \circ The subject tree(s) circled

 \circ Property boundaries, buildings which the tree(s) could strike, and parking areas; Proof of property ownership.

[optional] Photographs of the tree(s) (helpful to show the tree in context) [optional] Tie ribbon or some indicator on the tree

APPEALS:

Appeals are pursuant to MMC 20.80.230 and shall be submitted in writing to the City Clerk. Appeals of an administrative decision are heard by the hearing examiner at an open-record hearing where parties can submit new evidence to support their appeal. Notice shall be given to all parties of record on the date, time and place of the appeal hearing.

BACKGROUND:

Chapter 20.52 of the Medina Municipal Code (MMC) requires property owners to obtain a tree removal permit and to provide tree replacement mitigation for the following:

- Removal of any tree on private property that has a Diameter Breast Height (DBH) of 6 inches or more and is documented as a significant tree species by the city.
- Removal of any tree on private property that has a DBH of 6 inches or more and is documented as a significant tree species by the city where the tree removal is part of a new development or reconstruction.
- Removal of trees on public property or within the city right-of-way by a private property owner.
- Removal of trees within a shoreline setback by a private property owner.

HAZARD TREE DEFINITION:

A tree is defined as hazardous when it is assessed as a high to extreme risk rating using the International Society of Arboriculture (ISA) tree risk assessment methodology in its most current form. This assessment can only be performed by the City Arborist per MMC 20.52.200. They city arborist is an ISA certified arborist with the Tree Risk Assessment Qualification (TRAQ).
