## **General Situation:**

#### Latest Top line information:

Governor Inslee announces pause on county progressions to Phase 4. Inslee also extended the Safe Start proclamation until July 9th in anticipation of additional modifications that will be made imminently.

**Washington state reported 651 new cases** of coronavirus (July 6) as the national number topped 2.8 million. The increasing cases of COVID-19 in King County is highlighting the need to limit close contact

#### Background

The Washington State Emergency Operations Center is currently responding to an outbreak of respiratory disease caused by a novel (new) coronavirus that was first detected in China. The virus has been named "SARS-CoV-2" and the disease it causes has been named "coronavirus disease 2019" (abbreviated "COVID-19"). The Washington State Emergency Operations Center has been fully activated since January 22, 2020 with ESF 8 taking the lead in response efforts.

The Governor issued Emergency Proclamation 20-05 on Saturday, February 29, 2020. Ongoing executive orders and actions provide measures to reduce spreading of COVID-19.

The Washington State Emergency Operations Center is currently activated at Level one (1) Full Activation for the COVID 19 Response.

On Friday, March 13, 2020, President Trump declared a nationwide emergency pursuant to Sec. 501(b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. 5121-5207 (the "Stafford Act"). This increases federal support to the Department of Health and Human Services (HHS) in its role as the lead federal agency for the ongoing COVID-19 pandemic response.

#### **Proclamation Extensions**

**7/2/20** – Gov. Jay Inslee ordered a two-week pause on counties advancing phases under the Plan. Next week, Gov. Inslee plans to sign a proclamation that businesses across the state won't be allowed to serve customers who aren't wearing a facial covering. (Governor's televised COVID-19 update)

**7/1/20** - Gov. Jay Inslee issued a brief extension of the Safe Start proclamation until July 9, in anticipation of additional modifications that will be made early next week. This proclamation extends all the provisions of previous versions and adds new requirements for employers to cooperate with public health authorities in the investigation of COVID-19 cases and outbreaks, implementation of infection control measures, and more. The governor's office says updated Safe Start guidance will be issued tomorrow. Read the full proclamation here.



# **Cases Are Increasing Statewide**



Gov. Jay Inslee and Sec. of Health John Wiesman today announced a statewide requirement for businesses to require face coverings of all employees and customers. Under this proclamation, businesses may not serve any customer, services or goods, if they do not comply with the <u>state-wide face covering order</u>. The extension comes in response to growing case counts in counties across the state, and after last week's proclamation mandating the same requirement of businesses in Yakima County.

"We're doing this because of a spike in cases of COVID-19 all over the state," Inslee said. "The better we can protect ourselves from the virus, the better we can avoid repeating some of the painful measures we had to take in the spring to shut down the economy."
