General Situation:

On Friday, June 5th the Washington State Department of Health accepted King County's plan to allow for limited openings of recreational, social and business activities in a modified Phase 1 of the Governor Jay Inslee's Safe Start reopening plan. Activities may not begin until businesses are able to meet the state's public health guidance.

The State's plan creates four phases that gradually increase activities based on the prevalence of disease and the ability to mitigate community transmission of the virus. King County is currently in Phase 1.5 of the four phases, which allows for partial re-opening of some businesses and activities.

Nearly all types of activities that are allowed in Phase 2 are allowed in a modified Phase 1, just at lower capacities and with 30-minute time limits for indoor real estate, professional services, and retail services. Modified Phase 1 allows indoor activities at half of the capacity allowed by Phase 2 and at full capacity of what's allowed outdoors in Phase 2. *Please see summary table at end of report.*

The Washington State Emergency Operations Center is currently responding to an outbreak of respiratory disease caused by a novel (new) coronavirus that was first detected in China. The virus has been named "SARS-CoV-2" and the disease it causes has been named "coronavirus disease 2019" (abbreviated "COVID-19"). The

Washington State Emergency Operations Center has been fully activated since January 22, 2020 with ESF 8 taking the lead in response efforts.

The Governor issued Emergency Proclamation 20-05 on Saturday, February 29, 2020. Ongoing executive orders and actions provide measures to reduce spreading of COVID-19.

The Washington State Emergency Operations Center is currently activated at Level one (1) Full Activation for the COVID 19 Response.

On Friday, March 13, 2020, President Trump declared a nationwide emergency pursuant to Sec. 501(b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. 5121-5207 (the "Stafford Act"). This increases federal support to the Department of Health and Human Services (HHS) in its role as the lead federal agency for the ongoing COVID-19 pandemic response.

City of Medina

- Leadership is working on specifics for return to work and exploring options for returning to business. Social distancing, reviewing the layout of facilities to support NPI (Nonpharmaceutical interventions). Expectations (NPI), for example, wearing face coverings, social distancing, will be the new normal. Currently work is underway on a staff Return to work Plan. It appears Phase 2 would allow general officer workers to return to work. Phase 3 specifically references government buildings. Development services has begun office working with no public contact. Public Works is back in service working staggered shifts.
- Communication is being developed around updating residents on the opening of restrictions with reference to the City. Information shared via Medina Police Facebook, City Website and Twitter.

SUMMARY – PHASE 1.5

King County has not yet met key criteria to enter Phase 2 of the Safe Start plan and case counts are still unstable, so it will move forward with a modified approach, including partial re-opening of the following businesses and activities:

- Recreation and fitness
 - Only allowed outdoor with 5 -- not including the instructor -- or fewer people outside of household
- Gatherings
 - o Only allowed outdoor of 5 or fewer people outside the household
- Additional construction
 - o As outlined in Phase 2 guidance
- Manufacturing operations
 - o As outlined in Phase 2 guidance
- Real estate
 - 25 percent of building occupancy
 - o Indoor services limited to 30 minutes
- In-store Retail
 - 15 percent of building occupancy
 - o Indoor services limited to 30 minutes
- Personal Services
 - 25 percent of building occupancy
- Professional services
 - 25 percent of building occupancy
 - o Indoor services limited to 30 minutes for customers
- Photography
 - o As outlined in Phase 2 guidance
- Pet grooming
 - 25 percent of building occupancy
- Restaurants
 - No indoor dining allowed
 - Outdoor dining is permitted but seating at 50 percent of existing outdoor capacity.
