AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MEDINA, WASHINGTON AMENDING ORDINANCE NO. 978 TO ADOPT AND IMPLEMENT THE 2020 BUDGET; AND TO ESTABLISH AN EFFECTIVE DATE.
