AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters that we communicated to City management and Council in a letter dated February 21, 2020, related to financial condition. We appreciate the City's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the City of Medina from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Financial condition
- Small & Attractive assets – review of theft-sensitive assets to ensure adequate safeguarding of public resources
- Restricted funds – review the use of Real Estate Excise Taxes to ensure compliance with restricted purposes
- Contracts – review of compliance with vendor contract

INFORMATION ABOUT THE CITY

The City of Medina was incorporated on August 19, 1955, and currently serves approximately 3,000 residents. It is located in the eastern part of King County on Lake Washington and is contiguous to the cities of Bellevue, Clyde Hill and Hunts Point. The City provides services including police, planning and economic development, and public works.

An elected, seven-member Council governs the City. The Council appoints a Mayor, as well as a City Manager to oversee the City's daily operations along with its 24 full-time employees, one part-time, one on-call, and 15 seasonal employees. For the fiscal year 2018, the City operated on an annual budget approximately \$8 million.
