# H. OTHER BUSINESS

### 1A. Parking Related Low Impact Development (LID) Code Text Amendments:

Commissioners discussed the proposed amendment relating to parking.

ACTION: Motion Nelson second Reeves; To approve a recommendation of the Planning Commission by adopting the Parking Related Low Impact Development Code Text Amendments with an accompanying recommendation that Council adopt an ordinance requiring the LID Code be reviewed in five years. Approved 5-0.

### 1B. Discussion on Low Impact Development (LID) Code Text Amendments:

Miner reviewed the LID processing timelines with the Commissioners, reminding them that it needs to be completed by March 2019.

Kent gave a presentation on the proposed LID Code Text Amendments that are needed to comply with the Department of Ecology's municipal stormwater permits, with the focus on Landscape Screening.

Commissioners asked questions throughout the presentation and staff responded.

ACTION: Motion Nelson second Preston; To discuss the Landscape Screening Related Low Impact Development Code Text Amendments.

Commissioners discussed the motion and requested additional amendments to the proposed text amendments.

ACTION: Motion Nelson second Preston; To adopt the amendments discussed.

Miner confirmed she had the details of the Commissioners amendments.

ACTION: Motion Nelson second Preston; Staff will bring an updated Landscape Screening LID Code Text Amendment, with the discussed adopted amendments, to the next scheduled LID meeting where it will be approved by the Planning Commission via consent. Approved 5-0.
