Grumbach made the following announcements:

- Briefed Commissioners on an agreement reached between the City and KGM regarding KGM's appeal of the Planning Commissions conditions to the SR 520 CMP revision.
- Council will hold the 2016 budget hearing at their November 9th meeting. He
 noted that there would not be any budget included for the Comprehensive Plan
 Updates.
- Puget Sound Energy has applied for a tree permit to perform trimming maintenance around the power lines.
- Council approved moving forward with the Tree Management and Stewardship Plan, also known as the Urban Forest Plan.

Chair Reeves surveyed the Commissioners and it was decided to move Amendment 5 forward as written. Grumbach stated he would include the definition of gutters in amendment.

There was consensus among the Commissioners to move all the remaining proposed amendments forward for public hearing at the next meeting.
