The Planning Commission meeting of June 23, 2015, was called to order at 6:00 PM by Chair Reeves.

OTHER BUSINESS (6:15 PM)

1) Acknowledgement of Peter May's service

Chair Reeves gave a summary of Commissioner May's service on the Planning Commission. Reeves shared that May had started in 2010 and was involved in many projects, including the SMP, Tree Code, various zoning codes, cell towers, 84th St. improvements and non-motorized Comprehensive Plan improvements.

May expressed his greatest respect to the Commissioners and staff. He commented on the professionalism of everyone and the commitments made by all that get things accomplished.

Grumbach expressed his gratitude to May and thanked him for always being the voice of reason.

Schubring thanked May for his professionalism and mentorship.

Nelson said he was going to miss May's contributions to the dynamics of the group.

Carlson stated she appreciated the way May would always keep people on track of the topic at hand.

Reeves expressed how much he would miss May's wit, intelligence and common sense.

- 2) <u>2015 Mandatory Review and Update of the Comprehensive Plan Discussion</u> (review of documents accepted for hearing at February 24, 2015 meeting):
 - Draft of Amendments to the Comprehensive Plan
 - Draft Amendments to Critical Areas Ordinance/Development Regulations

Tess Brandon from the Watershed Company was present to answer any questions.

Grumbach reminded the commissioners that the overall purpose of the update is to satisfy State requirements for a mandatory review of the plan and regulations every 7 or 8 years to confirm consistency with the Growth Management Act.

Grumbach highlighting some key elements of the Comprehensive Plan including updating land use inventory using GIS, updates for population and housing units, adding official zoning map, a critical area guide map, updates to capital facilities, City Hall and Public Works shop. Grumbach progressed to explaining updates to the Critical Area Ordinance. He noted The Watershed Company did an evaluation of the plan using best available science and it was determined that there were several

sections of the Critical Area's Ordinance with best available science gaps that needed updating: primarily relating to wet-lands. There were also some changes to the geologically hazardous provisions and streams. Grumbach said the City has been in the process of developing a unified development code and would move the critical areas regulations from Chapter 18.12 to Chapter 20.50 as part of this effort.

Grumbach and the Commission discussed schedules for the July and August meetings. The Comprehensive Plan Hearing is scheduled for the July 28th meeting and there is a potential CMP hearing for the SR 520 project at the August 25th meeting.
