The Planning Commission meeting of April 28, 2015, was called to order at 6:01 PM by Chair Reeves.

MOTION PAPANO/ SECOND SCHUBRING TO APPROVE THE MINUTES OF THE MARCH 24, 2015 PLANNING COMMISSION MEETING. APPROVED 4 - 0. (COMMISSIONER NELSON NOT PRESENT) (6:09 PM)

AUDIENCE PARTICIPATION (6:10 PM)

There was no audience participation.

PUBLIC HEARINGS (6:10 PM)

1) Phase Two Tree Code Amendments

Grumbach recapped the process including reaching out to the community during Medina Days, holding an open house, hosting a town hall meeting and sending out a questionnaire. Grumbach summarized the purpose of the tree code as preserving the existing sylvan nature while allowing flexibility for home owners. He reviewed a few of the major changes to the code such as performance standards for property under development, simplifying the process for properties not under development, size of replacement trees and new city tree right-of-way requirements. Grumbach also corrected List 1 and List 4 in the Medina Suitable Tree Species List by noting the lists are based on Zone 8a and 9b and not Zone 7 as previously stated.

Chair Reeves opened the public hearing at 6:55 p.m.

- David Yee commented on, what he feels, is the lack of concern for individuals
 that have legitimate tree problems, stating the City should allow residents to
 resolve their tree issues without all the red tape. He also commented on the
 use of TRAQ vs. TRACE, hazardous trees and the tree code as a whole.
- Shree Wen thanked everyone for all their work on the tree code. She commented on having the option of planting shorter growing trees, such as the ones that are planted under power lines, so as to not block views. She also commented on the counting method used to determine re-planting requirements and clarification of right-of-way vs. home owner boundaries.
- Alex Morcos praised the Commission and staff on the job they have done with the tree code. He stated that if signed off today, most residents would be happy with the proposed code. Marcos also commented on the 6 inch restriction being too restrictive for most residence, 50 inch protected trees, replacement fees, and the City right-of-way tree replacement.

There was no other public hearing comment.

The Commissioned discussed and clarified sections of the public testimony and then moved on to tree code amendments.

MOTION MAY / SECOND NELSON ON PAGE 15, LINE 44, SUB-SECTION 2, TO ADD THE WORDS 'AND FEASIBLE' AFTER THE WORDS 'IF APPLICABLE'. (7:56 PM)

A lengthy discussion followed on the proposed amendments. Another motion for amendment was made:

MOTION MAY / SECOND PAPANO THAT THE TREE SPECIES ELIGIBLE LIST REQUIRED FOR RETENTION BE LIMITED TO LIST 4, SUB SECTION A AND C, NATIVE TREES AND; FOR CREDIT, THE LIST BE LIMITED TO LIST A, B AND C. (8:50 PM)

More discussion followed on the proposed amendments. Chair Reeves then called for a vote on the 3 proposed amendments.

AMENDMENT 1:

PAGE 23, LINE 19, SUB-SECTION K, TO CHANGE THE WORD FROM 'MAY BE WAIVED' TO 'SHALL BE WAIVED'. APPROVED 5-0. (9:07 PM)

AMENDMENT 2:

PAGE 15, LINE 44, SUB-SECTION 2, TO ADD THE WORDS 'AND FEASIBLE' AFTER THE WORDS 'IF APPLICABLE'. APPROVED 5-0 (9:07 PM)

AMENDMENT 3:

THAT THE TREE SPECIES ELIGIBLE LIST REQUIRED FOR RETENTION BE LIMITED TO LIST 4 SUB SECTION A AND C, NATIVE TREES AND; FOR CREDIT, THE LIST BE LIMITED TO LIST A, B AND C. APPROVED 4-1 SCHUBRING OPPOSED (9:08 PM)

ORIGINAL MOTION TO RECOMMEND THE CITY COUNCIL APPROVE THE AMENDMENTS TO THE MEDINA TREE CODE AS SET FORTH IN THE APRIL 28, 2015 DRAFT AND TO FORWARD THE RECOMMENDATION TO THE CITY COUNCIL AS AMENDED. APPROVED 5 – 0 (9:09 PM)
